#### Sophia End-User License Agreement ("Agreement")

#### Last updated: November 30, 2022

Please read this End-User License Agreement carefully before using Sophia.

### **Interpretation and Definitions**

#### Interpretation

The words of which the initial letter is capitalized have meanings defined under the following conditions. The following definitions shall have the same meaning regardless of whether they appear in singular or in plural.

#### **Definitions**

For the purposes of this End-User License Agreement:

**Agreement** means this End-User License Agreement that forms the entire agreement between You and the Company regarding the use of the Application. **Application** means the online application provided by the Company, named Sophia and accessible at the URL <u>https://www.sophiapro.com/</u>.

**Company** (referred to as either "the Company", "We", "Us" or "Our" in this Agreement) refers to Evoca North America Venture Inc., 2355, avenue Dalton, Québec, QC G1P 3S3 Canada.

**Content** refers to content such as text, images, or other information that can be posted, uploaded, linked to or otherwise made available by You, regardless of the form of that content.

Country refers to: Québec, Canada

**Device** means any device that can access the Application such as a computer, a cellphone or a digital tablet.

Licence refers to any license granted by the Company

**Third-Party Services** means any services or content (including data, information, applications and other products services) provided by a third-party that may be displayed, included or made available by the Application.

**User Sharing** permits You to share content of the Application with other users by allowing them to receive notifications or view each others' eligible Application data. **You** means the individual accessing or using the Application or the company, or other legal entity on behalf of which such individual is accessing or using the Application, as applicable.

# Acknowledgment

### License

#### **Scope of License**

The Company grants You a revocable, non-exclusive, non-transferable, limited License to use the Application strictly in accordance with the terms of this Agreement.

The License that is granted to You by the Company is to be used within the Application intended usage.

You may only use the Application on a Device that You legally own or control.

The License that is granted to You by the Company is to be used in a corporate context for individual or business responsibilities related to coffee machine management strictly in accordance with the terms of this Agreement.

#### **License Restrictions**

You agree not to, and You will not permit others to:

License, sell, rent, lease, assign, distribute, transmit, host, outsource, disclose or otherwise financially exploit the Application or make the Application available to any third party.

Copy or use the Application for any purpose other than as permitted under the above section 'License'.

Remove, alter or obscure any proprietary notice (including any notice of copyright or trademark) of the Company or its affiliates, partners, suppliers or the licensors of the Application.

### Content

#### **Content Restrictions**

The Company is not responsible for the entries, information or content of the Application's users. You expressly understand and agree that You are solely responsible for the Content and for all activity that occurs under your account, whether done so by You or any third person using your account.

You may not transmit any Content that is unlawful, offensive, upsetting, intended to disgust, threatening, libelous, defamatory, obscene or otherwise objectionable. Examples of such objectionable Content include, but are not limited to, the following:

- Unlawful or promoting unlawful activity.
- Defamatory, discriminatory, or mean-spirited content, including references or commentary about religion, race, sexual orientation, gender, national/ethnic origin, or other targeted groups.

The Company reserves the right, but not the obligation, to, in its sole discretion, determine whether or not any Content is appropriate and complies with this Agreement, refuse or remove any Content. The Company further reserves the right to make formatting and edits and change the manner to any Content. The Company can also limit or revoke the use of the Application if your account contains such objectionable Content.

As the Company cannot control all content generated by users and/or third parties on the Application, you agree to use the Application at your own risk. # Your Suggestions

# Term and Termination

This Agreement shall remain in effect until terminated by You or the Company. The Company may, in its sole discretion, at any time and for any or no reason, suspend or terminate this Agreement with or without prior notice. This Agreement will terminate immediately, without prior notice from the Company, in the event that you fail to comply with any provision of this Agreement. You may also terminate this Agreement by deleting your account on the Application.

Upon termination of this Agreement, You shall cease all use of the Application.

Termination of this Agreement will not limit any of the Company's rights or remedies at law or in equity in case of breach by You (during the term of this Agreement) of any of your obligations under the present Agreement.

### Indemnification

## Changes to this Agreement

The Company reserves the right, at its sole discretion, to modify or replace this Agreement at any time. If a revision is material we will provide at least 15 days' notice prior to any new terms taking effect. What constitutes a material change will be determined at the sole discretion of the Company.

By continuing to access or use the Application after any revisions become effective, You agree to be bound by the revised terms. If You do not agree to the new terms, You are no longer authorized to use the Application.

## Governing Law

The laws of the Country, excluding its conflicts of law rules, shall govern this Agreement and your use of the Application. Your use of the Application may also be subject to other local, state, province, national, or international laws.

### **Entire Agreement**
